# Mukhtar appointed HSBC M'sia CEO

**KUALA LUMPUR:** HSBC Bank Malaysia Bhd has appointed Mukhtar Hussain its new deputy chairman and chief executive officer (CEO) from Dec 15.

Mukhtar joined the HSBC group in 1982 as a graduate trainee, the bank said in a statement yesterday.

After 11 years of working in the group's London offices holding senior positions, he then moved on to the Middle East as CEO of HSBC Financial Services (Middle East) Ltd.

Mukhtar was responsible for building one of the first integrated investment banking businesses in the Middle East and North Africa.

He also established the initiative to create the first foreign investment bank in Saudi Arabia for HSBC.

In 2006, Mukhtar moved to London as global head of principal investments.

His most recent roles have been global CEO of HSBC Amanah, the Islamic financial services division of HSBC, and CEO of global banking and markets, Middle East and North Africa.
